Reasons given included siting of dwellings c.f. A345, proximity to 623 Piggott Close of car parking and visibility of windows from plot 1, layout not in keeping with existing properties in the area.

A working party is taking place on 10th June at the playground in Court Farm Road to clean the wet pour and tidy up. A resident has kindly agreed to provide water and electricity for the jet-wash.

The Clerk reported that no one as yet has come forward to take on the two empty allotments.

Community Allotment

The greenhouse on the Community Allotment has been fitted with with glass and is now water tight. The allotment is fully planted and flourishing. The Community Larder is well supported and has been decorated by the Art Group.

The Old Wilton Cart Track will be cut next week. The bench along the Corfe has collapsed and is being mended by the Village Handyman.
